Dear Parents and Guardians of OLA/DELTA Center Students,

We are planning an Earth Day Activity for our students to The Great Sand Dunes Nat'l Park on Thursday Apr. 23, 2015 as a service learning project for our students. This project is a Great Sand Dunes volunteer opportunity and hours will be tracked by the park as such. Letters are available verifying volunteer hours from the park.

This will be an all day activity leaving school promptly at 8:00am and returning to school at about 3:00pm. Parents/Guardians are welcome to attend with their student. For participation you will earn: a **Certificate of Service, 4 hrs. P.E. credit and class assignment credit.** Ask Mr. Dawson or your adviser for information about assignment credit.

Our task for the day will be to transplant trees in the area surrounding the new parking lot. This will provide shade, habitat and help reduce erosion in the area.

The following items will be needed for this fun outdoor activity. Bring plenty of water to drink. Bring snacks for break times to keep your energy up. Work clothes, work gloves, hat, sun screen, and work shoes or boots. Dress in layers. We know that weather in the Valley can change drastically in a short amount of time. We will be transplanting trees from one area of the Park to another which involves shovel work so plan well.

Our tentative schedule is to arrive at the Dunes at about 9:00am and begin activities at 9:20am. Lunch will be provided by the Great Sand Dunes and served at 12:30pm. We will leave the Dunes at 2:15pm to arrive back in Monte Vista by about 3:00pm.

It is important to understand this is a school activity for credit. To participate in this service learning project, you need to meet the following expectations:

- 1. Students will need to have a signed permission slip from their parent/guardian allowing you to participate on this day.
- 2. Students will need to be active participants in the day's activities at the Dunes. 3. Be passing at least three of your classes.
